RHBAA COMMISSIONERS POLICY**

CURRENT COMMISSIONERS:

Current Commissioners must turn in their commissioner's application with payment of dues postmarked by January 31. If they are a lifetime member, the commissioner application and monies submitted before the deadline are all that are needed.

If they are not a lifetime member, they must complete a membership application for the current year and remit payment for this before or along with the commissioner's application for it to be considered on time. **A commissioner's license will not be issued to anyone not holding a membership for the current year.**

It is very important that we have your updated information on file. Please fill out the shaded area on the commission's application completely to assure that our records are correct and sign where indicated. **All renewal applications must be POSTMARKED by January 31.**

PROSPECTIVE COMMISSIONERS:

New Commissioners will be voted on during the Winter Meetings each year. Any applications submitted during the previous year will be held until the Breeder's Committee meeting. **All new applications must be POSTMARKED by December 31.** All new applicants must be at least 21 and be a member for a **full calendar year** and be a member for the current year before being considered.

All sponsors listed on the application must be a current member and have been a member for a least 3 consecutive years, with no breaks in membership.

All prospective applicants will receive a letter from the Breeder's Committee after the Winter Meetings advising them of their status.
